Applications are invited for the post of Senior Residents and Tutor/Demonstrator in Kalpana Chawla Govt. Medical College, Karnal on yearly basis extendable upto a maximum 03 tenures, subject to satisfactory work and conduct report. Kalpana Chawla Govt. Medical College, Karnal is a permitted Medical College by NMC. The applicants must submit their application alongwith details i.e. complete correspondence address, contact numbers, Email address and details of educational qualifications in prescribed format with all self-attested documents alongwith prescribed fee in the Receipt & Dispatch Branch, Kalpana Chawla Govt. Medical College, Karnal **latest by 20.12.2023 upto 05:00 PM**. No application beyond the stipulated time period will be considered and will be straightway rejected. The prospective candidates should apply on the prescribed proforma obtainable from Office of Medical Superintendent, KCGMC, Karnal or downloadable from the College website i.e. www.kcgmc.edu.in.

Educational Qualification & Experience of Senior Residents, Tutor/Demonstrator:-

1. MBBS from Institution/University recognized by the NMC.
2. MD/MS/DNB in the subject concerned. In case the candidates having MD/MS qualification are not available, the candidates having diploma in the specialty concerned or training experience of 03 years as PG student in the subject will be considered for appointment.
3. Must be having a valid registration certificate either issued by NMC/Haryana State Medical Council. The same has been verified by the document verification committee at the time of documents verification.

Note:-Senior Resident Doctors (SRs) shall be postgraduate candidates of the corresponding specialty or department. Tutors shall be MBBS candidates. Demonstrators shall be postgraduate with Ph.D. in the subject to be appointed, and not having qualification of MBBS.

4. Score of the exit examination conducted by MCI/National Board of Examination, New Delhi for FMGE candidates will be considered as equivalent to MBBS score for the purpose of calculating the pre-merit of all the Foreign Medical Graduate (FMGs).
5. Other candidates possessing only a pass/fail certificate & no score card for the FMGE, the score will be considered as 50% only and pre-merit will be calculated accordingly.

Application Fees (Non-Refundable). A crossed Demand Draft worth Rs. 1000/- for General Category and Rs. 250/- for Reserved Categories (for Haryana Domicile only) in favour of Director, KCGMC, Karnal. 50% concession in the above fees is granted to the women candidates (both general and reserved category) as per Govt. Instructions. PH & ESM candidates are exempted from the application fee.

TERMS & CONDITIONS:-

1. Age should not be more than 45 years at the time of initial appointment. The benefit of relaxation of in upper age limit in respect of candidates belonging to SC/ST, BC, and ESM etc. will be as per Haryana Govt. instructions issued from time to time and are restricted to Haryana domiciles only.
2. The Senior Resident will be the governed by rules of Kalpana Chawla Govt. Medical College, Karnal which are at par with the rules currently applicable to the Senior Residents at Pt. B.D Sharma PGIMS, Rohtak.
3. The appointment is purely on yearly tenure basis extendable up to a maximum 03 tenures, subject to satisfactory work and conduct report. However, the services can be terminated immediately without prior notice, if the work and conduct are not found satisfactory.
4. The interview will be held in the office of Director, Kalpana Chawla Govt. Medical College, Karnal. The candidates must bring all the essential certificates/documents i.e. (Matriculation Certificate, MBBS/MD Mark sheets, Degrees, Experience Certificate, Registration attempt certificate of MBBS as well as MD/MS, Caste Certificate etc.) in original for verification at the time of interview.
5. Experience will be considered only if it is obtained from MCI/NMC recognized/permitted Medical College.

6. Incomplete application in any form & without self attested copies of educational certificates and other relevant documents will be rejected.
7. Number of posts can be increased or decreased on the basis of actual requirement against sanctioned posts without any prior information/notice.
8. In the interest of patient care and public interest if the exigency of the situation so demands, then Hospital administration reserves the right to change the posting of Senior Resident, Tutor/Demonstrator to any department.
9. No Separate Interview letter will be sent to the applicants and the information pertaining to the date of interview will be uploaded on College website,so all interested applicants are directed to visit the website of the institute on regular basis for all updates i.e. www.kcgmc.edu.in.
10. No TA/DA will be paid for attending the interview.
11. As per govt. notification No. 22/12/2019-1GS-III dated 25.02.2019 which stated that:-
"Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and will be filled from unreserved category."
12. The cutoff date for qualification shall be the date of publication of Advt. in newspaper/website.
13. The applicants who are already in Govt./Semi Govt./Corporation or Autonomous Body, should bring fresh, 'No Objection Certificate' at the time of interview, failing which the applicant will not be considered for interview, **NOC may not be older than 06 months counted from advertisement date of inviting of applications.**
14. The posts of Senior Residents, Tutor/Demonstrator are not faculty positions.
15. A candidate can apply maximum for three departments and not more than three departments in any case.
