Salary: Consolidated pay of Rs.25,000/- per month for M. Sc. (Agri.) in Agricultural Entomology/ M. Sc. (Horti.) in Entomology, consolidated pay of Rs.21,000/- per month for M.Sc. Zoology

Age: 22 to 35 years

Nature of work: To assist the Scientists in the Research projects (laboratory and field works) in the Division of Entomology

**Terms and Conditions:**
