3. **Classification** : *Group 'A' (Gazetted) (Non-Ministerial)*
4. **Name and No. of Posts**: *Junior Grade of MHS (GDMO Sub-Cadre) – 9*

5. **Pay** : *Level 10 in the Pay Matrix (Rs.56,100 – Rs.1,24,500)*
6. **Eligibility Conditions for Junior Grade of MHS (GDMO Sub-Cadre):**
  - 1) **Educational Qualification:**
    - a) MBBS Degree from recognized University.
    - b) Completion of compulsory rotating internship; candidates who may not have completed rotating internship shall be eligible to appear for the written examination provided that, if selected, he/she shall have satisfactorily completed the compulsory internship before the appointment.
    - c) Preference to be given for those who have rendered prior rural area service.
    - d) Permanent Registration from the Mizoram State medical Council.
  - 2) Working Knowledge of Mizo Language of at least Middle School standard.
  - 3) **Age Limit:**

A candidate must be between 21 years and 35 years of age on the last date of application. Upper age limit is relaxable by 5 years for SC/ST candidates.

*Provided that the upper age limit in all recruitment rules/service rules for Group 'A', 'B', 'C' and 'D' posts under the Government of Mizoram where upper age limit prescribed for direct recruitment is 35 (thirty-five) years shall be 37 (thirty-seven) years for direct recruitments in various posts under the Government of Mizoram for advertisements likely to be made after the commencement of these rules during the Calendar years of 2023 and 2024*
