Terms& Conditions

- 1. The position of Young Professional II is purely on temporary basis. Initial engagement of Young Professional II will be for one year which is extendable to the requirement of the services or till the completion of the project of the Young Professional II in the organization and satisfactory performance of the candidate after evaluation by the Director.
- 2. The selected candidates will not have any right for claiming pay scale or absorption against any regular post being vacant on a later date at this institute.
- 3. The candidates appearing for the written test cum interview should follow social distancing and wear mask inside the campus till the interview procedure gets completed.
- 4. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.
- 5. All eligible candidates are requested to be present 60 minutes before reporting time on the written test cum interview for necessary formalities and verification of documents.

- 6. Selected candidates will be required to produce all original documents at the time of Joining for verification purposes.
- 7. The selected candidate will be required to produce a medical certificate at the time of joining.
- 8. The Director, ICAR- SBI, Coimbatore reserves the right to cancel/postpone the interview without assigning any reason thereof.
- 9. The selected candidate will be working on a whole-time basis and will not be allowed to register himself/herself for any academic program viz., Ph. D etc.
- 10. The candidate will get the consolidated emoluments per month as mentioned against vacancy without any other allowances or liabilities on part of SBI or ICAR or funding agencies.
- 11. The minimum age for the above post is 21 years and maximum 45 years with relaxation as per rules.
- 12. The eligible candidate need not send an application in advance but must bring with them original documents (including one set of photocopy), one latest passport size photograph, and experience certificate in original if any at the time of interview.
- 13. The continuation of Young Professional II will depend upon the progress reviewed every six months.
- 14. No TA/DA will be paid to attend the interview.
- 15. The decision of the Director, ICAR-SBI, Coimbatore (Tamil Nadu) will be final and binding on all aspects. The Director shall also reserve the right to terminate the contract of the job as mentioned above, even before the completion of the project for which no appeal thereof shall be made.
