Now, it is proposed to conduct Walk-in- Interview on 11.02.2025 at 10.00 A.M for Teaching Associate in the Department of English at Agricultural College, Bapatla on contract as full time basis (purely on temporary).

1. Post : Teaching Associate
2. Name of the Department : English
3. No. of Posts : 1 No.
4. Duration of the post : 11 months from date of joining / filling of regular post, whichever is earlier
5. Essential Qualifications : a) B.A. (Lit) in English
b) M.A.(Lit) in English
6. Desirable qualification : a) Ph.D. in the relevant subject from the ICAR accredited Universities/Colleges
b) Experience in UG/PG teaching, research and extension in recognized projects/organizations.
c) Publications in the peer-reviewed (NAAS rated) / Scopus indexed / Web of Science / UGCCARE listed journals.
7. Remuneration (Per month) : a) Rs. 35,000/- P.M. for PG Degree holders
b) Rs. 40,000/- P.M. for Ph.D. Degree holders
8. Date and Time of Interview : 11.02.2025 10:00 a.m.

B) Terms and Conditions:

- 1) The Individual is engaged **purely on temporary and contractual basis** which will be terminated after completion of 11 months (or) filling of regular staff, whichever is earlier.
- 2) The incumbent shall not have any claim (or) shall have any right to claim for any regular appointment in University / any government organization.
- 3) The incumbent shall not have any claim (or) shall have any right for further continuation of contractual service.
- 4) Concealing of facts or canvassing in any form shall lead to disqualification of the candidature at the time of selection (or) termination even during the contractual engagement period.
- 5) Contractual engagements can be terminated at any time without prior notice or assigning any reason thereof.
- 6) The engaged persons may also leave the contractual service on their own by giving one-month notice, otherwise to be paid one-month salary before leaving.
- 7) The selected candidates will be required to undergo medical examination at their own expenses as per the rules for ensuring their physical fitness before appointment.
- 8) No T.A. & D.A. will be given to the candidates appearing for interview.
- 9) The decision of the selection committee for the above post will be final and binding in all respects.
- 10) The Associate Dean has right to cancel or postpone the interviews for the said post, for the said date due to any unavoidable circumstances / reason thereof.
