1.	Applicants will have to make the payment of application fees through the online mode as under: ₹1000/- (for General/ OBC candidates). SC/ST candidates, Women applicants and PWBD applicants
	are exempted from payment of application fee.
2.	Applicants should fill in the online application form provided in the link below: <b>https://online.iitg.ac.in/recruitment.</b> No physical copy of application / document is required to be sent.
	The link will be activated from 5.00 pm (IST) on <b>15.03.2025</b> Last date of receipt of online application: <b>31.03.2025 till 05:00pm (IST).</b>
3.	The post shall be filled on Deputation basis only. Relaxation of age for the concerned categories will be considered as per applicable GOI rules.
4.	Since the post is to be filled up on Deputation only, private candidates are not eligible.
5.	The period of Deputation shall be for a maximum period upto 28.04.2027 or till the regular
	incumbent of the post returns from deputation or till further orders, whichever is earlier. Other
	terms and conditions of Deputation shall be as per the Institute rules.

6.	Reserved category applicants shall be required to upload the latest Caste certificate issued by the Competent Authority as per Govt. of India directives issued from time to time.
	Applicants belonging to OBC(NCL)/ EWS category will have to upload latest OBC(NCL)/ EWS certificate from Competent Authority in the prescribed format as per Govt. of India norms, which should not be more than one year old (from closing date of application).
	Similarly, PwBD applicants shall be required to upload proof of disability mentioning the percentage of disability issued by the Competent Authority.
7.	The applicant will be responsible for the authenticity of submitted information/documents and photograph. It is the responsibility of the applicant to assess his/her own eligibility to the post in accordance to the advertisement, if it is detected at any time in future, during the process of selection or even after appointment that the applicant was not eligible as per the prescribed Recruitment Rule of the Institute which could not be detected at the time of selection for whatsoever reason, his/her candidature/appointment shall be liable to be cancelled/terminated immediately.
